PRIMARY DUTIES / RESPONSIBILITIES

Diagnostic (anatomic) pathologists examine histological sections for lesions and interpreting the results of specific tests in cytology. Gross dissection examinations are also conducted.

KEY ACCOUNTABILITIES:

Clinical

- To participate in routine specimen handling and reporting duties in the lab as determined by the Delegated Person and Company Director
- Participate in the cut-up roster.
- Typically an expectation of reporting around 80-100 histopathology cases per day. Daily quality reporting would regularly include reports with clinical correlation, images and educational hyperlink.
- To provide consultative and advisory services directly to referring clinicians in regard to patient care and best practice principles.
- To undertake other duties as agreed with the Delegated Person and Company Director, including teaching and research if required.
- To foster and maintain close links with medical colleagues to ensure a coordinated provision of service and assist in marketing when required.
- To ensure scientific and clinical effectiveness of the Lab.
- To participate in relevant quality assurance programmes and other quality activities such as the implementation of cancer reporting protocols, RCPA QAP and NATA accreditation.
- To manage your workflow to ensure timely, safe and competent reporting of all specimens
